Meter# 3: Daily Average, Projected Monthly and Recent Water bill are all above budget. Property was suffering from an Irrigation leak which has since been repaired. Water bill reflects loss of water during leak. We will continue to monitor and will update after next billing cycle.

Pressure Testing:

In order to ensure that each resident is receiving optimal water pressure, we have recorded the building psi (pounds per square inch). Desirable water pressure is between 45 and 75 psi. High pressure can cause loud pipes, pinhole leaks in joints, and water hammering; pipes loudly banging inside of walls due to air in the water lines. While low pressure could be a sign of multiple problems; mineral deposits in pipes, leaks, or a faulty pressure regulator.

Building **16927** pressure is at 60 PSI. <u>Building pressure reading is 60 PSI, pressure is average, no concern.</u>

Building numbers 16929-16999 are 90 PSI. (See recommendations).
