Pressure Testing:

In order to ensure that each resident is receiving optimal water pressure, we have recorded each building's psi (pounds per square inch). We have organized all the readings in order of highest pressure readings to lowest pressure, see chart below. Desirable water pressure is between 45 and 75 psi. High pressure can cause loud pipes, pinhole leaks in joints, and water hammering; pipes loudly banging inside of walls due to air in the water lines. While low pressure could be a sign of multiple problems; mineral deposits in pipes, leaks, or a faulty pressure regulator.

The buildings have high pressure, please schedule evaluating the pressure at each building and adjusting the pressure at the boiler room gradually. (See Below)
