Hose bibs: each building is equipped with 1 hose bib. All hose bibs on property are UNCAPPED. There are no visible pressure regulators on the property.

Backflows: there are a total of 4 backflow assemblies on the property (1 Irrigation, 1 domestic, and 1 fire with Bypass). There are no leaks. None are cage protected.
